No. GVN/2025/07/RCT/1419/573/D :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Veterinary Officer, Class II, in the Gujarat State Services, under the Office of Principal Chief Conservator of Forest and Head of Forest Force, Gujarat State, namely :-

1. (1) These rules may be called the Veterinary Officer, Class II, in the Gujarat State Services, Recruitment Rules, 2025.

(2) They shall come into force from the date of their publication in the *Official Gazette*.
2. Appointment to the post of Veterinary Officer, Class II, in the Gujarat State Services, under the Office of Principal Chief Conservator of Forest and Head of Forest Force, Gujarat State, shall be made by direct selection.
3. To be eligible for appointment by direct selection to the post mentioned in rule 2, the candidate shall, -
 - (a) not be more than 35 years of age:

Provided that the upper age limit may be relaxed in favour of the candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;
 - (b) possess a bachelor's degree of Veterinary Science and Animal Husbandry or "bachelor's degree of Veterinary science"

obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other educational institution recognised as such or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956; and have been recognised under Indian Veterinary Council Act, 1984 or a recognised veterinary qualification included in the first schedule or second schedule of the Indian Veterinary Council Act, 1984;


(c) possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967; and

(d) possess adequate knowledge of Gujarati or Hindi or both.

4. The candidate appointed by direct selection shall be required to get himself registered with the Gujarat Veterinary Council or Veterinary Council of India under the Indian Veterinary Council Act, 1984 at the time of his appointment, if he is not so registered.
5. The candidate appointed by direct selection shall be on probation for a period of two years.
6. The candidate appointed by direct selection during his probation period shall be required to undergo pre-service training and pass the post - training examination in accordance with the provisions of the Gazetted Officer's Pre-Service Training and Examination Rules, 1970.
7. The candidate appointed by direct selection during his probation period shall be required to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.

8. The candidate appointed by direct selection shall be required to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.
9. The candidate appointed by direct selection shall be required to undergo such training and pass such examination as may be prescribed by the Government.
10. The candidate appointed by direct selection shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
