**Constitution
of India.**

No.GVN/2025/(11)/FED/ROR/e-file/6/2023/1517/D-2: - In exercise of the powers conferred by the proviso to article 309 of the Constitution of India the Governor of Gujarat hereby makes the following rules to provide for regulating the recruitment to the post of Livestock Inspector, Class III, in the Subordinate Service, under the Gujarat Forest and Environment Department namely:-

1. (1) These rules may be called the Livestock Inspector, Class III, in the Subordinate Service, under the Gujarat Forest and Environment Department, Recruitment Rules, 2025.
(2) They shall come into force on the date of their publication in the *Official Gazette*.
2. Appointment to the post of Livestock Inspector, Class III, in the Subordinate Service, under the Gujarat Forest and Environment Department shall be made by direct selection.
3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall, -
 - (a) Not be more than 33 years of age:

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

- (b) have passed three years Diploma in Animal Husbandry from any of the Universities established or incorporated by or under the Central or State Agricultural or Veterinary University Acts :

Provided that the candidate shall not be eligible who have obtained requisite qualification through Distance learning Mode.




(c) Possess the basic knowledge of computer application as prescribed in Gujarat Civil Services Classification and Recruitment (General) Rules, 1967; and

(d) Possess adequate knowledge of Gujarati or Hindi or both.

4. The Provisions of rule 9(A) of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in respect of a candidate appointed by direct selection.
5. The candidate appointed by direct selection shall require to undergo such training and to pass such examination as may be prescribed by the Government.
6. The candidate appointed by direct selection shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
