Preamble:

The Gujarat State Board for Wildlife has been constituted vide this department Resolution dated 21/09/2017 mentioned at serial no. (1) above. A proposal to partially reconstitute members of State Board for Wildlife due to expiry of terms of members of state legislature was received from PCCF(WL) vide letter under reference (2), which was under consideration of Government.

Amendment

(1) In partial modification of the G.R. at reference (1) above, the State Government is pleased to partially reconstitute the Gujarat State Board for Wildlife, as under :-

C	Three Members of State Legislature (i) Shri Nareshbhai Maganbhai Patel, Gandevi (ii) Prof. Kuberbhai Mansukhbhai Dindor, Santrampur (iii) Shri Babubhai Bhimabhai Bokhiriya, Porbandar	Member Member Member
E	Eminent conservationist, ecologist and environmentalist (ix) Shri Motilal Vasava (S.T.), Former MLA, Dediapada.	Member

- (2) The term of members other than those who are ex-officio members will be of three years from the date of this Resolution.
- (3) The term of the members of the State legislature shall be co-terminus with their tenure as MLA.
- (4) The headquarters of the Board will be at Gandhinagar.
- (5) Procedure to be followed by the Board:-
 - (a) The Board shall meet at least twice in a year at such place as the State Government may decide.
 - (b) The Board shall regulate its own procedure for the conduct of business. (including the quorum)
 - (c) No act or proceeding of the Board shall be invalid merely by reason of the existence of any defect in the constitution thereof or any irregularity in the procedure adopted by the Board not affecting the merits of the case.
- (6) Duties of the State Board for Wildlife:-

It shall be the duty of the State Board for Wildlife to advise the State Government

 - (a) In the selection and management of areas to be declared as Protected Areas;
 - (b) In formulation of policy for protection and conservation of wildlife and specified plants;
 - (c) In any matter relating to amendment of the Schedule.
 - (d) In relation to measures to be taken for harmonizing the needs of tribal and other forest dwellers with the conservation of wildlife; and
 - (e) In any other matter connected with the protection of wildlife, which may be referred to it by the State Government.
- (7) The non-official members of the Board shall be entitled to receive T.A & D.A. in accordance with Finance Department GR Dated 18/02/1982 as amended from time to time.
