

Circular:

Seniority of the employees is to be published as per the provisions of seniority laid down vide resolution/circular cited above at (1) and (2). Post based considerations of the vacancies for determination of seniority is introduced vide G.R. cited above at (2). Thus, calendar year is to be treated as unit year for seniority w.e.f. 2014. Final seniority list of the officers appointed to Gujarat Forest Service, Class-II in the cadre of Assistant Conservator of Forest during 01/01/2008 to 31/12/2013 has been drawn up vide circular cited above at (5) whose last seniority number is 498. Further publication of the seniority list was under consideration of the department.

2. Appointment to the cadre of Assistant Conservator of Forests by direct selection and by promotion is to be made in the ratio of 1:2 as per Notification cited above at (3). Accordingly details of posts is annexed as per Statement-I. The draft seniority list of Assistant Conservator of Forests of recruitment year 2014-2017 is published herewith as per Statement-II for verification of details particularly their date of birth, category and date of appointment. Statement-II comprises seniority numbers from 499 to 609. Training period of direct recruit Assistant Conservator of Forests is to be counted for the purpose of seniority as per the provisions of G.R. cited above at (4), hence, their seniority is determined accordingly.



3. The Principal Chief Conservator of Forest & HoFF, Gujarat State is requested to forward a copy of the provisional seniority list to all the officers concerned and the endorsement with receipt from every officer must be forwarded to this department. Names of the officers who have been retired/left cadre have also been included in the list for the purpose of determining the inter-se seniority.
4. The seniority of direct recruits will be subject to successful completion of probation and issuance of its order by competent authority. This seniority would be subject to final outcome of the all pending court cases in relation to direct recruitment advertisement of GPSC No. 209/2009-10 and also any other court case pending in any court or/and order issued by any competent court in any of the connected matters.
5. It is requested that the modification/correction(s)/addition(s)/omissions/infirmities, if any, may kindly be furnished in writing with supporting documents if any, within 30 days from the date of the issuance of this circular so that it can be verified in the light of prevailing rules and may be incorporated in the final seniority list. Requests received after the stipulated time will not be entertained in ordinary circumstances. If any discrepancy is being pointed out by officer concerned, it should be counter verified by the Principal Chief Conservator of Forest & HoFF, Gujarat State before forwarding the same to this department.
6. This circular is placed on website of the department 'www.fed.gujarat.gov.in' for information and ready reference to act upon by the officers concerned.
