2. The Pay and Accounts Officer, Gandhinagar is authorised to fix their pay in accordance with the instructions issued by Department of Personnel and Training vide the aforementioned Office Memorandum.

3. With non-functional financial upgradation, the Officers will be entitled to use such upgraded pay scale for the purposes of allotment of residential quarter entitlement to TA-DA and entitlement to the Transport Allowance. Revised Pay Scale from such financial up gradation will not be considered for other perks and perquisites and any other allowances given by the Government where the entitlement is tied with the nature of responsibilities in office. Salary Slip of such officers will bear 'Non Functional upgradation' marked on it to make a distinction.


4. The non-functional financial up-gradation granted under these orders will be personal to the officer and would not bestow any right to the officer to claim promotion or designation of the higher post or deputation benefits.

5. Pending promotion of the officer to the scale of pay against a sanctioned cadre post of ex-cadre post, even after getting non-functional financial up-gradation, said officer will continue to officiate in the post he has been officiating before grant of such pay and would not be entitled to any re-designation of the post.
6. At the time of promotion the pay in the grade will not be fixed again.
7. Previous sanction of non-functional up-gradation would not entitle any officers to automatic promotion when vacancies arise. Procedure for promotion as laid down in IPS/IFS guidelines will have to be followed afresh and suitability judged afresh.
