## Procedural guidelines for the permissible activities as per the provisions of the CRZ Notification 2011: For various projects

Following procedure is followed by the Gujarat Coastal Zone Management Authority /State Government while scrutinizing the applications submitted for CRZ clearance

#### A.Documents to be submitted by the applicant alongwith Form-I:

1.Form –I per Annexure- IV of the CRZ Notification, 2011, duly filled in.

Rapid EIA report including marine and terrestrial component except for construction projects such as Housing Scheme in CRZ are specified as CRZ –II and construction involving more than 20,000 sq. mts built up area in CRZ-II and less than 20,000 sqm mtr.

2.Comprehensive EIA report with cumulative studies for projects in the stretches classified as low and medium eroding by Ministry of Environment and Forests, Government of India based on scientific studies and in consultation with the State Government.

3.Disaster Management Plan

4.A scaled map(in 1:4000) indicating Low Tide Line & High Tide Line and CRZ area (duly demarcated by an agency authorized by the Ministry of Environment and Forests, Government of India), proposed activities, landuse within 7 km radius, latitude, longitude, land use pattern etc.

5. Superimposition of the proposed activities on the above map

6.The "**Consent to Establish**" from the Gujarat Pollution Control Board for the projects involving discharge of effluent, solid wastes, sewage Ports and harbours, etc.

7.Details regarding the cost of the project and Scrutiny fees by Demand Draft in favour of "Gujarat Maritime Board A/c Coastal Regulation Zone Management Authority" payable at Ahmedabad, as per the following slab system.

Project Cost

Scrutiny fees

- Up to Rs. 5 crores Rs. 25000/-
- Between Rs. 5 crores and 100 crores Rs. 1 lakh
- Rs. 100 crores and above
  Rs. 5 lakhs
- 8. No Objection Certificate of Gujarat Maritime Board.

9.Oil Spill Contingency and Disaster Management Plan, including Emergency Preparedness Plan, if required.

10.Risk Assessment Report, including the worst case scenario (if applicable).

11.VesselTraffic Control Management plan (for sea and road traffic).

12.In addition to the above documents, the applicant shall also submit the following undertakings (signed by the person not below the rank of the Director of the Company).

a)An undertaking to implement all the suggestions and recommendations given by the consultants in their EIA and Risk Assessment reports.

b)An undertaking to bear the cost of the external agency to be appointed by F&ED, GOG for supervision/ monitoring of the proposed activities.

c)An undertaking to carryout Comprehensive Environmental Impact Assessment and Risk Assessment reports in case of stable coast arera.

d)An undertaking that the project proponent shall not tap the ground water to meet with the water requirements during construction and operational stages.

e)An undertaking that the construction labour shall be provided with adequate amenities including the water supply, sanitation and fuel to ensure that they do not ruin the existing environment.

f)An undertaking that the camps of the construction labour shall be located outside the CRZ areas and no waste including the construction debris shall be disposed of in the sea / creek or into the CRZ areas.

g)An undertaking that the socio-economic upliftment programme shall be implemented in consultation with the District Collector / District Development Officer.

h)An undertaking that the greenbelt development programme shall be implemented in consultation with the Forests Department.

i)An undertaking to support financially the National Green Corps Scheme being implemented by the GEER Foundation in Gujarat in consultation with the F&ED.

## B. <u>Site Visit, to be carried out by the GCZMA/State Government</u> for site verification, if necessary :

Officers of this Department shall carry out the site visit, if required. Moreover, the department may ask for the presentation on the Environment Impact Assessment and other reports.

## C. Presentation:

- 1. The project proponent shall have to make a presentation before the members of the CZMA for their projects, various activities to be carried out in CRZ areas and on the EIA report along with the scientists or experts who have prepared the EIA report and about the likely impacts on the marine environment due to their proposed projects and mitigation measures thereof.
- 2. The project proponent shall have to revise or modify the EIA report based on the various observations/suggestions of the GCZMA, if any. and shall submit the same to GCZMA for getting recommendation of the GCZMA.

# Procedural guidelines for small dwelling/residential houses in CRZ area for local community:

- 1. The Project Proponent shall make a Formal application for construction of the Building alongwith the list of the proposed activities at the respective Local Urban Authority/Nagar Palika.
- 2. A Certificate from the Chief Officer of the NagarPalika /Local Urban Authority about providing water supply and sewage disposal connection.
- 3. A Certificate from the Chief Officer of the Nagar Palika/Local Urban Authority that the proposed construction is in accordance with surrounding landscape and local architecture..
- 4. A Certificate from the Chief Officer of the Nagar Palika / Local Authority that the location of the proposed construction project is in accordance with the Development plan of the area.
- 5. A certificate from the Chief Officer of the Nagarpalika/Local Urban Authority mentioning that the proposed project falls in the residential zone(for residential buildings)
- 6. A certificate from the Chief Officer of the NagarPalika/Local Urban Authority regarding existence of authorized construction and road between the High Tide Line and the proposed construction site.
- 7. A certificate from the Chief Officer of the NagarPalika/Local Urban Authority mentioning that the proposed construction is in conformity with building bylaws of the local Authority.
- 8. Map from the NagarPlika/Local Urban Authority showing the location of the proposed construction vis-avis the LTL/HTL and the CRZ boundary.

- 9. A lay out including the floor plans, elevation etc of the proposed construction alongwith the details @the construction cost.
- 10. An undertaking from the applicant that he/she shall not draw the ground water from the CRZ area.
- 11. After receiving above documents, along with the formal application from the applicant, routed through the Nagar Palika/Local Urban Authority, the CZMAs shall scrutinize the same keeping in mind the various provisions of the CRZ Notification, and recommend to reject/grant the CRZ clearance within a period of 15 days
- 12. The State Government in Town Planning Department/ Local Urban Authority/Nagar Palikas may accordingly issue/reject CRZ clearance based on the recommendation of the SCZMA within a period of one month.
